## Pre-Notification For Upcoming Designation Of Transnational Organized Criminal Elements

In July 2011, the White House issued a new strategy for combating Transnational Organized Crime (TOC) placing a greater priority on the threat posed by transnational criminal organizations (TCOs).

- --In order to combat this threat, the President concurrently issued Executive Order (E.O.) 13581, which imposes economic sanctions on four TCOs the Yakuza, the Brothers' Circle, the Camorra, and Los Zetas and also provides authority for the Secretary of the Treasury to impose sanctions on individuals and entities that support the designated TCOs as well as to name additional TCOs.
- --The United States designated two individuals and one entity related to the Yakuza, as well as seven individuals associated with the Brothers' Circle, under E.O. 13581 on February 21, 2012.
- --The U.S. Treasury Department on February 21, 2012 publicly designated for sanctions the following individuals and entity related to the Yakuza:
  - Yamaguchi-gumi (entity)
  - Kenichi Shinoda (individual)
  - Kiyoshi Takayama (individual)
- -- The U.S. Treasury Department on February 21, 2012 publicly designated for sanctions the following individuals related to the Brothers' Circle:
  - Vladislav Vladimirovich Leontyev (individual)
  - Gafur Akhmedovich Rakhimov (individual)
  - Kamchybek Asanbekovich Kolbayev (individual)
  - Vasily Alexandrovich Khristoforov (individual)
  - Aleksey Alekseyevich Zaytsev (individual)
  - Lazar Gurgenovich Shaybazyan (individual)
  - Aleksandr Leonidovich Manuylov (individual)
- -- The United States has a strong interest in working collaboratively with Malta to safeguard the international financial system from the threat posed by TCOs, and would be interested in knowing what additional identifying information Malta may have and what actions the government might be able to take to target these individuals and entities.
