## NOTE FOR INFORMATION

Reporting requirements covered by the Business of Insurance Statements ("BoIS") under Insurance Rule 12 of 2007 during the Solvency II Preparatory Period

Insurance and Reinsurance undertakings authorised to carry on business in terms of the Insurance Business Act Cap.403 ("undertakings") shall be required to submit the last Business of Insurance Statements ("BoIS") as per Insurance Rule 12 of 2007 based on the calendar ending 31<sup>st</sup> December 2015 within the timelines highlighted in Part H of the BoIS.

To reduce the reporting burden on the undertakings falling within the Preparatory period thresholds and maximise the efficiency of time and resources needed by all the undertakings in preparing for Solvency II, all the undertakings (including those undertakings which do not fall within the Preparatory period thresholds) shall be given the <u>option</u> to either submit the <u>full</u> set of BoIS templates (as applicable to the undertaking) or to submit a <u>subset of the BoIS templates</u> as follows:
