Repeal of insurance rules made under the Insurance Business Act

Rule pursuant to article 4 of the Act

- 1. (1) This Insurance Rule repealing the insurance rules issued under the Insurance Business Act ("this Rule") is made by the competent authority pursuant to article 4 of the Insurance Business Act (Cap. 403).
 - (2) This Rule shall come into force on the 1st January 2016.
