

Build Your Future Competition!

The Malta Financial Services Authority (MFSA) (hereinafter referred to as 'we') is offering individuals on Campus ('you'), the opportunity to participate in the MFSA Build Your Future game (the 'Competition') for the chance to win one of two iPads subject to the following terms and conditions.

Terms and Conditions

1. By participating you are eligible to win the following prize (the 'Prize')
 - 1.1 One iPad, 6th Generation, 32GB with inbuilt WIFI
2. Competition Period:
 - 2.1 Competition starts on Monday 30th September 2019 and ends on Friday 4th October 2019 ('Competition Period')
 - 2.2 You can participate in the competition on Monday 30th September till Thursday 3rd October between the hours of 9:00am to 4:00pm and from 9:00am to 01:00pm on Friday 4th October (each of such period hereunder referred to as the 'Event').
3. Eligibility:
 - 3.1 In order to be eligible for registration to win the Prize, you must be above 16 years of age and follow [MFSA on Instagram](#) or like the [MFSA Facebook page](#).
 - 3.2 You cannot participate in the Competition more than once for the duration of the Competition Period.
 - 3.3 MFSA employees shall be excluded from participation in the Competition.
4. How to participate:
 - 4.1 There must be one person (the 'Participant') playing the Competition. For the avoidance of doubt, participation of groups consisting of two or more persons is strictly prohibited.
 - 4.2 Each round of the Competition shall be of a duration of one minute. The Final score shall be calculated in accordance to the height of the tower. 1 point shall be given for every cm built.
 - 4.3 The tower built must remain intact and free standing after the completion of the task and time has lapsed. It cannot wobble or fall. If the tower falls over, the participant is disqualified. All pieces from which the tower is assembled need to be disassembled after judges have inspected the tower and points have been awarded.
 - 4.4 The participant with the highest score during the Event, will be asked a question pertaining to the MFSA. If answered correctly the participant will be the Final Winner.
 - 4.5 Should the finalists have the same amount of points, a retake of the competition is to be done at a later date as determined by the MFSA.
 - 4.6 Ten additional bonus points shall be awarded to the participant for following us either on the MFSA Instagram or Facebook profile. Any participant who engages in any action, which is prohibited under the provision of these terms and conditions, shall be disqualified.
5. Prize:
 - 5.1 Participants shall not be eligible to win more than one prize during the whole event.
 - 5.2 Each score will be recorded and the two individuals with the highest score and ability to answer the final question posed by MFSA will be announced by name by the event presenters on Tuesday 8th October 2019. The two individuals with the highest score shall be contacted directly by the event presenters. Announcement of the winner will also be posted on the MFSA Social Media platforms together with your Photos.
 - 5.3 The Prizes awarded cannot be exchanged in return for cash or any other products and/or services.
 - 5.4 We shall not be held liable, for any reason whatsoever, if the competition is terminated, cancelled and/or postponed to another date. In this event of cancellation or postponement of the Competition we shall not be obliged to offer an alternative Competition date.
