Important Changes Affecting Various Reporting Submissions

The purpose of this Circular is to inform Licence Holders within the Investment Services sector of updates to the validation rules pertaining to reporting submissions uploaded to MFSA LH Portal. The validation rules will include both changes to the current file naming conventions, as well as the introduction of new validation rules. Such changes will come into effect as from **Monday 10 July 2023**.

Tables providing a break-down of the updated validation rules are provided in <u>Annex 1</u>.

Please note that the naming convention of the ZIP files will remain unchanged. The following naming convention should only be used for the individual files uploaded in the LH Portal within the mentioned ZIP files, as follows:

EntityCode_ReportingPeriod_ReturnName

Where:

EntityCode	LH Portal Authorised Person ID.
Reporting Period	The period for which the Regulatory Submission relates. Not to be confused with the submission period. Shall be composed of the first three letters of the month name (in capital letters) and the year, structured as: MMMYYYY
ReturnName	The name of the return as indicated in Annex 1.





As an example, when a Licence Holder (EntityCode: ABCD) is submitting the Management Letter for the financial year ending 30 June 2023, the following naming conventions are to be used:

ZIP File:ABCD_JUN2023_AFDIndividual File:ABCD_JUN2023_ML

Following the date on which the new validation rules become applicable, returns containing files that do not follow the new naming conventions will be rejected by LH Portal. In such cases, the submission will not be considered as submitted to the Authority in terms of the applicable regulatory obligations.

Any documentation to be submitted to the Authority which is not listed in Annex 1 shall be submitted in a zip file using the following naming convention: **EntityCode_ReportingPeriod_OTH.zip**. In such instances, the file names of the contents within this zip file are not validated.
